Empowerment Through Advocacy

Inclusion BC's advocacy program provides direct one-to-one advocacy support for people with disabilities and their families. This is a free service for people across the province.

The information we learn from the people we support and from our research strengthens Inclusion BC's capacity to increase understanding of barriers at local, provincial and national levels.

This first-hand information is critical as we meet and consult with regional and provincial groups across the province, making a difference not only in the lives of the individual people we support, but at a systemic, organizational level.

Inclusion BC participated in the Re-imagining Community Inclusion consultations by bringing forth the messages we heard through our advocacy program. In addition, regular communication occurs between Inclusion BC and various ministries where again, the issues that families are experiencing are brought forth.

Inclusion BC's Annual Learning Event

Inclusion BC hosted its 43rd annual learning event in Victoria, BC from May 23-25, 2019. The event was co-hosted by Community Living Victoria and welcomed 500 delegates to the Victoria Conference Centre. We offered over 50 workshops on topics ranging from inclusive education to employment to health care and the arts. There were learning opportunities for community support professionals, self-advocates, family members, executives, students and inclusion allies. We featured six live arts performances, two keynote speakers—Dr. Al Condeluci and Dr. Leyton Schnellert—and one participatory theatre production, Romance, Relationships and Rights!

Supporting families to find their voices and become champions for inclusion

Kids Can't Wait Gathering

Inclusion BC as part of the Kids Can't Wait Working Group co-hosted families, advocates, agencies, and organizations at our *Kids Can't Wait Gathering* in October 2019. This helped us develop a Community Action Plan to improve outcomes for children and families who receive early years supports and services in B.C. with 4 areas of focus:

- Collaborative Services: Build strong collaborative approaches between ministries and between community agencies and ministries.
- Family-centred: Emphasize a family-centred approach to support that builds the capacity of families to care for their children.
- Timely Resources: Seek sufficient capacity to meet the needs of families in a timely way.
- Equitable Access: Advocate for equitable access to services that are appropriate and available to families where and when they need them.

Blooming Together

With our local partners in Victoria, we brought families together for the *Blooming Together Gathering*. The purpose was to grow and strengthen the family network by sharing knowledge, strengthening advocacy skills, and developing community support. We focused our discussion on:

- Rights, Processes, and Advocacy: develop the skills to become a champion for inclusion.
- Hopes, Dreams, and Planning: support a vision of inclusion with diverse planning tools.
- Resilience and Selfcare: be intentional about building family resilience.
- **Our inclusive community:** strengthen the network of families in Greater Victoria.

Loon Lake: Retreat & Re-emergence

The Inclusion BC weekend retreat at Loon Lake provided an opportunity for our Self Advocacy Advisory Committee, Family Advisory Committee, and special guests to meet in person and discuss their shared experiences, and map a path forward together.

Features of Inclusive Schools

Our Back-to-school campaign in September 2019 emphasized the theme that all students belong in the classroom and sought to raise awareness and understanding of the values and features of inclusive education.

Inclusive education means designing schools, classrooms, programs and activities so that all students participate and learn together. Inclusive public neighbourhood schools are the heart of our communities and of quality education systems.

Some ideas at the core of our inclusive education campaign are:

- All students are welcomed and valued for who they are.
- All students are supported to set personal goals and build on individual strengths.
- All students have equitable access to learning, with accommodations and support as required to overcome systemic barriers and discrimination.
- All students are supported to interact, play and collaborate with other students their own age.
- Parents are welcomed as respected partners in their child's education and local school community.
- School-wide commitment to upholding a safe, welcoming and supportive culture that emphasizes belonging and respect for diversity.

Inclusive Education Working Group

From February to August 2019, Inclusion BC participated in the Inclusive Education Working Group as part of the Ministry of Education's Funding Model Review process. The Working Group's final report includes key considerations for the potential implementation of a new funding model. Our key recommendations included:

- Clear Economic Modelling: Clear economic modelling needs to be made publicly available prior to full implementation so that everyone can understand how funding will flow to districts and classrooms that include students with diverse needs.
- Prioritized Support: Clarity on how the new model allocates appropriate funding and helps to fulfill a commitment to prioritizing support for individuals and communities with the highest needs.
- Implementation Assistance: Confirmation that support required to assist districts with the implementation of a new model will be worked out with each district prior to full implementation.
- Specific Timelines: Provide specific timelines for funding implementation moving forward, including stakeholder communication and engagement.

Restraint and Seclusion

We also continued to follow up our earlier work on stopping restraint and seclusion. All school districts were requested by the Ministry to have policies in place based upon the 2015 Provincial Guidelines on the use of restraint and seclusion. We undertook a review to assess district compliance with this directive and found that:

- As of November 2019, 56 school districts have adopted a policy on the use of restraint and seclusion.
- Four school districts had a draft policy or were in the approval process.

Inclusive Education Awards

Six B.C. educators were named as recipients of the 2019 National Inclusive Education Awards. The awards were hosted by Inclusion BC, the Family Support Institute of BC and Inclusive Education Canada.

The awards honour teachers, support staff and educational leaders who demonstrate leadership in ensuring that all students, especially those with extra support needs, are given full access to education and included in all aspects of school life. This 2019 winners include classroom teachers from elementary schools in Oliver and Maple Ridge, three educational assistants from New Westminster Secondary School, and the registrar at the University of Victoria.

MentorAbility

British Columbians with disabilities are discovering career goals through MentorAbility

MentorAbility is a national initiative which promotes the employment of people with disabilities through mentoring experiences in which job seekers with disabilities are matched with individual mentors in their field of interest. MentorAbility provides businesses, non-profits and public sector employers with opportunities to promote engagement in the workplace for persons with disabilities, recognize skills and potential, and develop rewarding and lasting relationships. Inclusion BC delivers the service across BC with the support of members and community partners.



READY WILLING & ABLE

Ready, Willing & Able

Since the launch of this program, 374 British Columbians with intellectual disabilities and Autism Spectrum Disorder have found work through Ready, Willing & Able.

Our partnership with the national Ready, Willing & Able (RWA) initiative continues to advance the inclusion of persons with intellectual disabilities and Autism Spectrum Disorder in BC workplaces through the business case approach. In Phase II, RWA is also supporting persons with intellectual disabilities and Autism Spectrum Disorder to pursue self-employment opportunities and post-secondary education. With employer partnerships across the province such as Costco, Purolator, Home Depot, Delloite and Sodexo, RWA continues to create diverse pathways towards employment. RWA participated in key provincial inclusive employment initiatives, including providing the keynote speech for the Chartered Professionals in Human Resources of British Columbia and Yukon (CHRP) Annual Diversity and Inclusion Symposium. RWA also co-hosted the first Inclusive Hiring Fair in Metro Vancouver Area with MentorAbility, to enhance employment opportunities for persons with intellectual disabilities and Autism Spectrum Disorder.

Inclusive Housing for All

A primary goal in the first year of our plan to advance inclusive housing was to gather data to better understand and communicate the housing needs of people with intellectual disabilities. CLBC contracted with BC Non-Profit Housing Association (BCNPH) to conduct a survey and series of focus groups. Inclusion BC began a learning journey with the First Nations and Indigenous Studies program at UBC by looking to develop a deeper understanding of the housing needs of Indigenous people and their families.

Early results from BCNPH reflect the following:

- Over half of the people surveyed would choose a different living situation.
- Roughly 35% of people would prefer to move as soon as possible.
- When asked, do you have a plan for your loved one? Approximately 70% of people reported no.

During the 8-month research project, which included a literature review and a series of interviews with Indigenous people, it became clear that our research method did not match Indigenous protocol or the way in which Indigenous people

share information. We discovered how imperative it is to work directly and alongside Indigenous leaders as allies to support their self-identified housing needs.

We also strengthened our local presence through several workshops, a presentation, and exhibit at the Union of BC Municipalities (UBCM) conference. A new joint campaign designed to deepen these relationships and build the capacity of local communities is coming soon. Watch for the launch of "Key to Home".

The tour was sponsored by Lifetime Networks Victoria, Port Alberni Association for Community Living and the Chilliwack Society for Community Living.

The Alumni team featured Maple Leafs stars Rick Vaive, Al Iafrate, Mike Krushelnyski, and ten others.

The goal of the hockey tour was to promote community inclusion, especially for people with developmental or intellectual disabilities.

Jeff Gilbank, Director of the Chilliwack Society for

Community Living, said, "We are using a common bond – hockey and the Toronto Maple Leafs Alumni – to bring together people of all abilities to celebrate inclusion and diversity."

at Lifetime Networks Victoria, said, "The immediate benefit of this event will be the reduction of social isolation for people with disabilities who will be welcomed and celebrated. The long-term benefit will be to strengthen Inclusion BC and our local community service providers."

Craig Summers, Executive Director at Port Alberni Association for Community Living, summed up the success of the event, "It's was a fun, family-friendly night! And everyone came out and showed their support for community

inclusion, diversity, and hockey!!"




